Re: Notice of Copyright Infringement and Violation of BlueHost.com's Service Agreement

Dear Sir/Madam:

We represent Infomastery LLC ("Infomastery") in connection with copyrighted materials that have been improperly and illegally posted on a website by one of your registrants. We are writing BlueHost.com as the registrar, registrant and provider of web hosting services for the domain name saltydroid.info regarding use of the domain name to infringe Infomastery's copyrights.

We understand that BlueHost.com serves as a "privacy service" for the true registrant of saltydroid.info. We trust that BlueHost.com's policies allow it to reveal the registrant's identity and contact information in cases where the domain name is being used to violate or infringe the copyrights and other legal rights of our client. Accordingly, based on the information below, we ask that BlueHost.com forward the true registrant's contact information to us so that we can address this issue with the registrant directly. We also ask that BlueHost.com terminate its services related to the hosting of the website at saltydroid.info for copyright infringement and other violations of BlueHost.com's Terms of Service Agreement (the "Service Agreement").

Infomastery registered and operates a website at socialmediamoneysystem.com, where consumers can purchase online downloadable software in which Infomastery owns the copyrights. Infomastery recently discovered what appears to be a blogging website at saltydroid.info. This blog contains links Internet users could use to download Infomastery's copyrighted software free of charge. The links are not publically available, and their posting on the saltydroid.info websites is without permission and constitutes copyright infringement. Copies of the relevant web pages at saltydroid.info are attached for your reference.

Infomastery moved its software to a new online location promptly after discovering the links posted on saltydroid.com. Accordingly, those links no longer point to active web pages. Based on information on the saltydroid.info website, however, it appears that several people were able to download Infomastery's software before the links were disabled. The blog on saltydroid.com also indicates that the blogger plans to continue his attempts to locate the software and again make it available for public download.

As I am sure you are aware, BlueHost.com's Service Agreement prohibits subscribers from engaging in certain prohibited activities. Under Section 9.1 of the Service Agreement, engaging in these activities constitutes a material breach, which subjects the subscriber's account to immediate termination. We believe the material posted on saltydroid.info regarding our client and its software violates, at a minimum, sections 9.3, 9.4 and 9.6 of the Service Agreement, which relate to prohibited offerings, profanity and violations of intellectual property rights, respectively. A copy of the relevant portions of the Service Agreement is attached for your reference. Unauthorized use of copyrighted material is also prohibited by the Digital Millennium Copyright Act.

Based on the above, we ask that BlueHost.com immediately disable all hosting services for the saltydroid.info website and provide us with the name and contact information for the registrant of the saltydroid.info domain name so that we may contact him or her directly regarding this matter.

We look forward to your prompt attention and cooperation. If you have any questions or require additional information, please do not hesitate to contact me.

9. PROHIBITED USES

1. **Breach of Terms and Account Termination.** The uses of BlueHost.Com Services set forth in this section 9 hereinbelow are prohibited. The engaging in any prohibited use as set forth herein by Subscriber or by any affiliate or subscriber of Subscriber (as determined in the sole discretion of BlueHost.Com) constitutes a material breach of these Terms and will subject Subscriber's account to immediate termination without notice.
2. **Spamming.** Spamming, whether or not it overloads the Services or disrupts service to BlueHost.Com's Subscribers, is prohibited. The term "Spamming" includes, but is not limited to, the sending of unsolicited bulk and/or commercial messages over the Internet, maintaining an open SMTP policy, or sending to any mailing list that is not double opt in. BlueHost.Com requires that all email messages contain an automated opt out . We do not allow purchased lists. BlueHost.Com's Subscribers are required to follow all rules in the Can Spam Act (<http://www.ftc.gov/bcp/edu/pubs/business/ecommerce/bus61.shtm>) as well as our company spam rules. BlueHost.Com reserves the right to determine, in its sole and absolute discretion, whether e-mail recipients were part of an opt-in email list. Irrespective of whether an email campaign constitutes Spamming as defined herein, BlueHost.Com allows a MAXIMUM of 500 emails per hour to be sent from any individual hosting account.
3. **Prohibited Offerings.** No Subscriber may utilize the Services to provide, sell or offer to sell the following: controlled substances; illegal drugs and drug contraband; weapons; pirated materials; instructions on making, assembling or obtaining illegal goods or weapons to attack others; information used to violate the copyright(s) of, violate the trademark(s) of or to destroy others' intellectual property or information; information used to illegally harm any people or animals; pornography, nudity, sexual products, programs or services; escort services or other content deemed adult related.
4. **Profanity.** Profanity or profane subject matter in the site content and in the domain name are prohibited.
5. **Private Information and Images.** Subscribers may not post or disclose any personal or private information about or images of children or any third party without the consent of said party (or a parent's consent in the case of a minor).
6. **Violations of Intellectual Property Rights.** Any violation of any person's or entity's intellectual property rights, rights of privacy, rights of publicity or other personal rights is prohibited. BlueHost.Com is required by law to remove or block access to content appearing on or through the Services upon receipt of proper notice of copyright infringement (see "Copyright Infringement Notice Information" below).
7. **Misrepresentation of Transmission Information.** Forging, misrepresenting, omitting, or deleting message headers, return mailing information and/or Internet protocol addresses to conceal or misidentify the origin of a message is prohibited.
8. **Viruses and Other Destructive Activities.** Use of the Services for creating or sending Internet viruses, worms or Trojan horses, or for pinging, flooding or mail bombing, or engaging in denial of service attacks

is prohibited. It is also prohibited for any Subscriber to engage in other activity that is intended to disrupt or interfere with, or that results in the disruption of or interference with, the ability of others to effectively use the Services (or any connected network, system, service or equipment) or conduct their business over the Internet.

9. **Hacking.** "Hacking" and related activities are prohibited. 11. **Export Control Violations.** The exportation of encryption software outside of the United States and/or violations of United States law relating to the exportation of software is prohibited. Subscriber may not export or transfer, directly or indirectly, any regulated product or information to anyone outside the United States without complying with all applicable statutes, codes, ordinances, regulations, and rules imposed by U.S. federal, state or local law, or by any other applicable law.

1. A signature of a person authorized to act on behalf of the owner of the exclusive right that is allegedly infringed. Identification of the copyrighted work that is claimed is being infringed, or, in the case of claimed infringement of multiple copyrighted works, a representative list of such works.
2. Identification of the material that is claimed to be infringing or is the subject of infringing activity and that should be removed or access to which should be disabled, with information reasonably sufficient to permit us to locate the material.
3. Information reasonably sufficient to permit us to contact the person giving the notification, such as an address and telephone, and, if available, an electronic mail address at which such person may be contacted.
4. A statement that the person giving the notification has a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law.
5. A statement that the information in the notification is accurate, and under penalty of perjury, that the person giving the notification is authorized to act on behalf of the owner of the exclusive right that is allegedly infringed.


11. GENERAL

1. **Promotional Pricing.** BlueHost.Com may periodically offer "free" or discounted services or credits in connection with a promotional offer, including, without limitation, free domain name registration. Such promotional offers are honored only in connection with the specific promotional package to which they apply. In the event a Subscriber downgrades or otherwise changes his/her/its subscription to a subscription to which a promotional offer does not apply, Subscriber will forfeit any unused free credits offered under the promotional package and BlueHost.Com will charge Subscriber the prevailing fees for any free credits redeemed by Subscriber under the promotional package.
2. **Backups.** For its own operational efficiencies and purposes, BlueHost.Com from time to time backs up data on its servers, but is under no obligation or duty to Subscriber to do so under these Terms. IT IS SOLELY SUBSCRIBER'S DUTY AND RESPONSIBILITY TO BACKUP SUBSCRIBER'S FILES AND DATA ON BLUEHOST.COM SERVERS, AND under no circumstance will BlueHost.Com be liable to anyone FOR DAMAGES OF ANY KIND under any legal theory for loss of Subscriber FILES AND/or data on any BlueHost.Com server.
3. **Monitoring and Disclosures.** All activities occurring on, in, and/or via the Services or any website hosted by BlueHost.Com may be monitored, recorded, and examined by any authorized person, including as well law enforcement. In general, BlueHost.Com does not monitor its Subscribers'
